  - (d) Inclusion of students with disabilities/ special need as per provision of the Persons with Disabilities Act, 2016.
- 7. The School shall follow the syllabus on the basis of curriculum laid down by appropriate authority
- 8. No unrecognized classes shall run within the premises of the school or in any other place in the name of School.
- 9. The School building plan must have been approved by the competent authorities as per relevant rules. The School building or other structures and the land are to be used only for the purposes of education and skill development.
